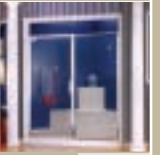
BEMA membership is an important asset, in the bath enclosure industry.

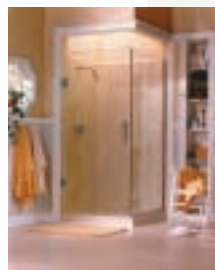
